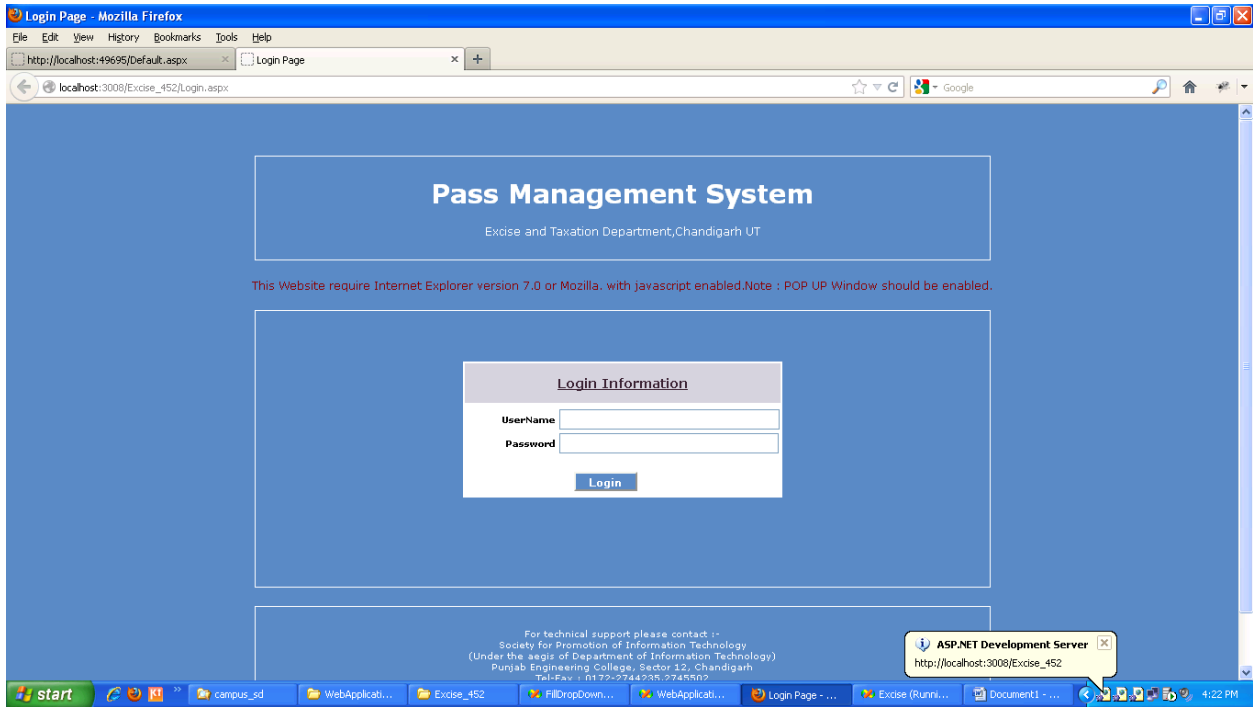
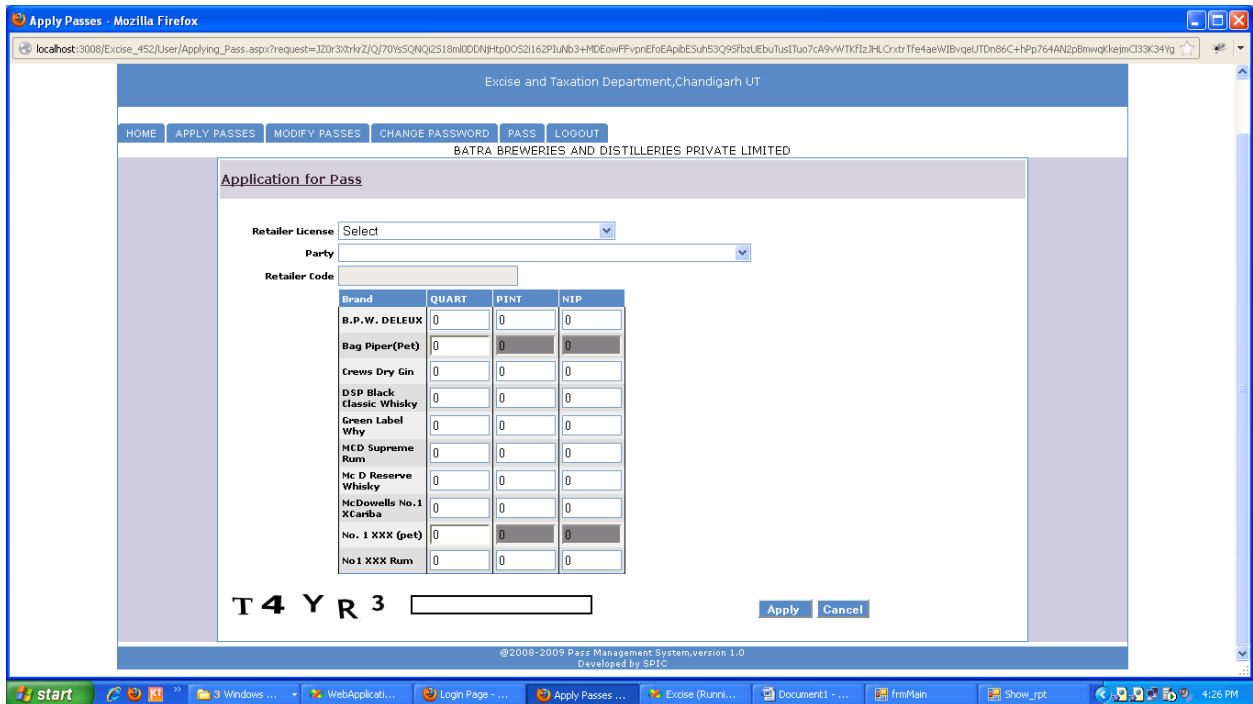

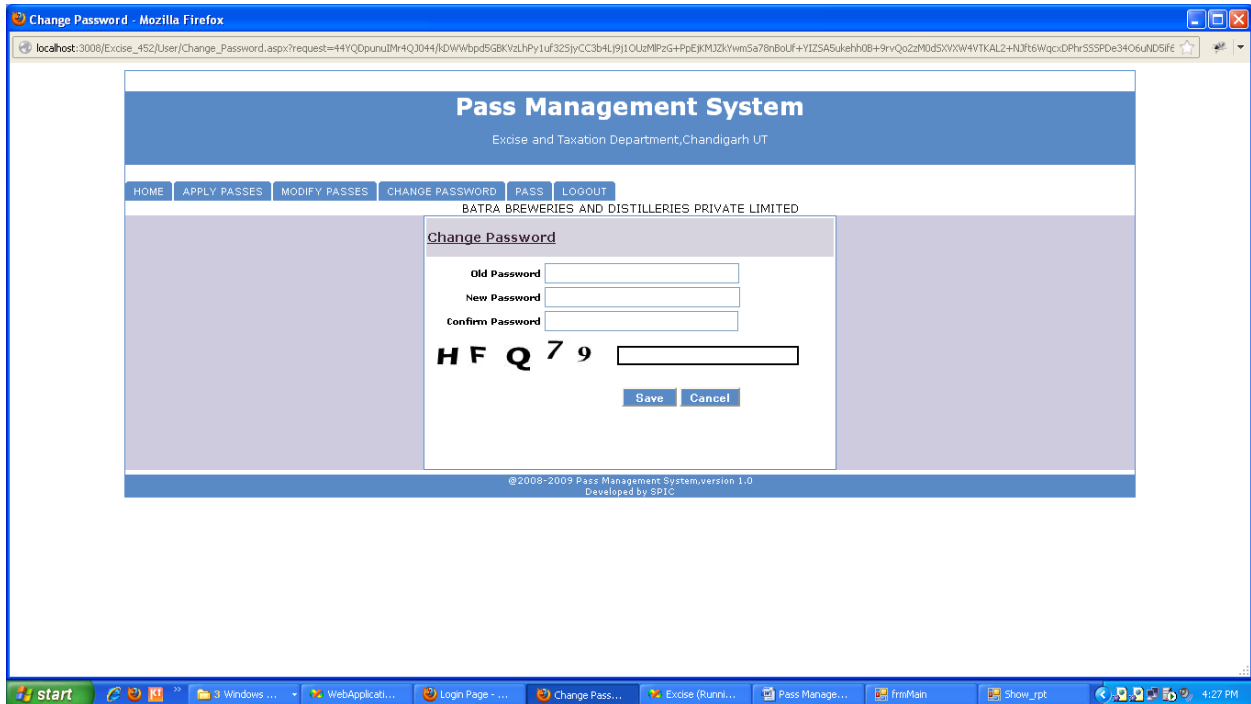
Login Screen to authenticate the User.

Interface to allow user to change their password at any time.


